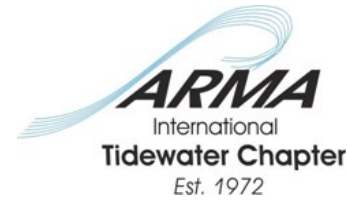

Gene Fishel has served as Senior Assistant Attorney General and Chief of the Computer Crime Section in the Virginia Attorney General's Office since 2007. He directs prosecutions of computer trespass, computer fraud, identity theft, and child exploitation cases. He serves as a Special Assistant United States Attorney across the state where he prosecutes computer crime cases in federal court. He also monitors organizations' compliance with Virginia's database breach notification laws, drafts legislation for the Virginia General Assembly, trains law enforcement and prosecutors statewide, and educates the public on issues involving computer crimes. Prior to joining the Attorney General's Office, he served as law clerk for the Second Judicial Circuit in Virginia Beach. He received his J.D. from Wake Forest University and a B.A., magna cum laude, from James Madison University.
